**ORDER DIRECTING STATUS UPDATE
AND WITHDRAWING ORDER OF CANCELLATION**

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificate of service authority of North County Communications Corporation (North County or the Company) to provide basic local exchange telecommunications services in Missouri. Staff's motion stated that North County failed to submit an annual report due to the Commission for calendar years 2019, 2020, and 2021. In addition, the Company failed to file its Statement of Revenue report and pay the annual assessment for fiscal year 2023. A deadline for responses was set, but none was received.

On May 12, 2023, the Commission issued an order canceling the Company's certificate of service. That order becomes effective June 11, 2023.

On May 24, 2023, North County filed its Annual Reports¹ and Statement of Revenue.

The Commission will direct its Staff to advise as to the status of North County's reports and statement of revenue. As the Commission's order canceling the

Company's certificate of service is not yet effective, the Commission will withdraw that order pending the receipt of Staff's status report.

THE COMMISSION ORDERS THAT:

1. Staff shall file a status report as discussed in the body of this order no later than June 23, 2023.
2. The Commission withdraws its Order Canceling Certificates, issued on May 12, 2023.
3. This order is effective when issued.
