## ORDER GRANTING EXTENSION OF TIME TO FILE ANNUAL REPORTS

Issue Date: April 23, 2009 Effective Date: May 3, 2009

On April 10, 2009, Central Rivers Wastewater Utility, Inc. filed an application asking the Commission to extend the time within which it is required to file its 2008 annual report from April 15, 2009, to September 15, 2009. Later on April 10, the Commission's Staff filed a response indicating its support for an extension until July 15, but opposing Central Rivers' request for an extension until September 15. On April 22, Central Rivers filed a reply indicating its willingness to accept Staff's proposed extension to July 15.

Commission Rule 4 CSR 240-3.335 requires all sewer utilities to submit an annual report to the Commission on or before April 15 of each year. However, that rule allows a utility to request an extension of greater than thirty days by filing a pleading before April 15, stating the reason for and the length of the requested extension.

Central Rivers' pleading meets the requirements of the rules and the relief the company requests is reasonable. Therefore, the Commission will extend the time within which Central Rivers shall file its 2008 annual reports to July 15.

#### THE COMMISSION ORDERS THAT:

The time within which Central Rivers Wastewater Utility, Inc., shall file its
 2008 annual reports is extended to July 15, 2009.
