MOTION FOR EXTENSION OF TIME FOR RESPONSE

COMES NOW Bandwidth.com CLEC, LLC, (Bandwidth) through undersigned counsel, pursuant to 4 CSR 240-2.050(3), and moves for the Commission to allow time until December 11, 2009, for Bandwidth's response to AT&T Companies' Motion to Suspend and Investigate Tariff (AT&T's Motion). In support of this motion, Bandwidth states as follows:

1. Bandwidth seeks additional time to attempt to resolve matters raised in AT&T's Motion. The time frame provided in the Commission's October 28, 2009, **Order Setting Time for Response** is not sufficient to accomplish this objective. Grant of this motion will facilitate the parties' attempts to resolve this matter.

2. To accommodate additional time for discussions with AT&T and Staff, Bandwidth has extended the effective date of its proposed tariff for 30 days, to December 22, 2009, and requests an extension of time for its response, to December 11, 2009. Undersigned counsel has spoken with counsel for AT&T and Staff regarding this request. They do not object to this request, contingent on the extension of the tariff effective date, and a provision for time to reply to Bandwidth's response, to the agreed-upon date of December 18, 2009. Thus, Bandwidth also requests the Commission to set December 18 as the deadline for Staff's recommendation or response, as well as for AT&T Missouri to file its reply to Bandwidth's response, if any.

WHEREFORE, Bandwidth.com CLEC, LLC, respectfully requests that the Commission issue its Order that Bandwidth's response to AT&T Missouri's motion be filed no later than December 11, 2009, and that Staff's Recommendation or Reply and AT&T Missouri's Reply, if any, be filed no later than December 18, 2009.
