Last year when we filed our Annual Reports for Qwest Communications Corporation (both IXC and CLEC) we explained to Janis Fischer that Qwest Communications Corporation is a subsidiary of Qwest Communications International Inc. (QCII) and does not separately publish its revenues in an SEC 10-K. Its revenues are included in the total QCII published revenues. We offered to provide the total QCII revenues, but were told that was not necessary and that the explanation would be included with our annual report submission.

This explanation also applies to Qwest Interprise America, Inc. which is also a subsidiary of Communications International, Inc.
