**NOTICE OF DISMISSAL**

Come now Petitioners Alma Telephone Company, Chariton Valley Telephone Corporation, and Northeast Missouri Rural Telephone Company, and notify the Commission that each of these three Petitioners hereby dismiss their complaints pending in this consolidated proceeding against Respondent T-Mobile USA Inc., with prejudice to the refiling thereof.

These three Petitioners, and T-Mobile USA Inc., have entered into and had approved interconnection agreements resulting from arbitration, which agreements were effective January 13, 2005, and in addition these three Petitioners and T-Mobile USA Inc. have entered into and effectuated a Settlement Agreement for traffic terminating to these three Petitioners prior to January 13, 2005.
