Discontinuance in Providing Video Service
from Consolidated Communications of Missouri Company d/b/a
Consolidated Communications

Dear Mr. Woodruff:

In accordance with Section 67.2685, RSMo, this letter serves as Notice to the Missouri Public Service Commission (the "Commission") by Consolidated Communications of Missouri Company d/b/a Consolidated Communications ("Consolidated") that on August 15, 2023, Consolidated will surrender/cancel its Video Service Authorization and cease to provide video services to all franchise areas in each political subdivisions originally granted and authorized to Consolidated by the Public Service Commission of the State of Missouri in Case No. KA-2008-0411.

Case No. KA-2008-0411 was originally granted to FairPoint Communications of Missouri, Inc., d/b/a/ FairPoint Communications, and subsequently, by Case No. KA-2019-0208, the Commission granted FairPoint Communications of Missouri, Inc. to change its name under which it operates its video service franchise authorization to Consolidated Communications of Missouri Company d/b/a Consolidated Communications.

The decision to sunset video service was made after careful consideration by Consolidated, and while Consolidated's video service will be decommissioned on August 15, 2023, we want to be clear Consolidated will continue to provide competitive broadband and voice services to residents and businesses in the political subdivision we currently operate in.

This notice of Consolidated's discontinuation of video service is also being provided to each Political Subdivisions where Consolidated is currently authorized to operate as a video service provider, provided via United States Postal Service (USPS) First Class Mail. As a reference, we have noted where applicable, the approximate number of current customers (23 in total) subscribing to Consolidated's video service in each Political Subdivision. Some of the customers are located within the corporate limits of a city, town, or village while other customers are located in various unincorporated areas within the counties listed. Consolidated is currently in the process of notifying its video service customers of the August 15, 2023, discontinuation of Consolidated's video service. Consolidated's initial customer notice was made July 3, 2023, sent via letter by USPS First Class Mail. Consolidated will make two additional notice mailings to its video service customers prior to the discontinuation date. In addition to the notice mailings, Consolidated is including a special message on its July and August customer bill statements advising of the discontinuation of Consolidated's video service. Consolidated will also make outbound calls to each video service customer to help ensure the customer is aware of this service elimination. Further, beginning August 1, 2023, Consolidated will provide video screen splashes on its video broadcast system, alerting/reminding customers of the August 15th turn-down date and actions to take.

Consolidated will make timely and appropriate notice to the FCC of the discontinuation of Consolidated's video franchise service.
