On August 29, 2022, Aero Communications, LLC. (Aero) filed a letter requesting the Commission to cancel its certificate of service authority to provide interexchange and non-switched local exchange carrier service, and its certificate of service authority to provide basic local telecommunications services, in the State of Missouri, effective immediately. The company also requested cancellation of its tariff for interexchange eservices with tracking number YX-2006-0514. Aero states that it has no active customers in Missouri.

The Commission will direct its Staff to respond to that notice.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a response to the request filed by Aero no later than September 13, 2022
2. This order shall be effective when issued.
