- 1. KMC has no overdue annual reports or assessment fees.
- 2. KMC will offer its basic local service as a separate and distinct service in accordance with Section 392.455(4) RSMo.
- 3. Section 392.240(1) should be added and Rule 4 CSR 240-32.050(3)-(6) should be removed from the waivers listed in paragraph 21 of the original application. Accordingly, paragraph 21 is amended to read as follows:
  - 21. KMC Data is willing to comply with all applicable Commission rules, and is willing to meet all relevant service standards, including but not limited to, billing, quality of service, and tariff filing and maintenance. However, consistent with the Commission's treatment of other certificated competitive local exchange telecommunications

companies, KMC Data requests that the following statutes and regulations be waived for its basic local exchange telecommunications service offerings, in accordance with Mo. Rev. Stat. § 392.420 and Mo. Code Regs. Ann. tit. 4 § 240-32.010(2):
