4 This is the prehearing in File
5 No. EA-2014-0136. This prehearing conference is in the
6 matter of the application of Union Electric Company
7 d/b/a Ameren Missouri for permission and approval and a
8 certificate of public convenience and necessity
9 authorizing it to construct, install, own, operate,
10 maintain and otherwise control and manage solar
11 generation facilities in O'Fallon, Missouri.

12 I am Ron Pridgin. I'm the regulatory law
13 judge assigned to preside over this prehearing
14 conference. It's being held on February 19, 2014. We
15 are in the Governor's Office Building in Jefferson City,
16 Missouri. The time is one o'clock p.m.

19 Electric Company.

3 JUDGE PRIDGIN: Ms. Hernandez, thank you.
4 On behalf of the Office of Public Counsel,

6 MR. MILLS: On behalf of the Office of Public
7 Counsel and the public, my name is Lewis Mills. My

10 JUDGE PRIDGIN: Mr. Mills, thank you.
