The Commission granted Competitive Interactive Technologies registration to provide IVolP services in the State of Missouri in File Number DA-2016-0265.


The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Competitive Interactive Technologies' IVolP registration.
