ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On May 2, 2018, the Staff of the Missouri Public Service Commission filed a pleading which recommended that Artisan Infrastructure, Inc.'s ("Artisan") Interconnected Voice over Internet Protocol registration in the State of Missouri be cancelled at the company's request. The Commission granted Artisan a registration of authority to provide iVoIP service in the State of Missouri in File Number DA-2015-0027.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's recommendation is received, the Commission may cancel the certificate based on Staff's recommendation.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.


