ORDER CANCELING IVOIP REGISTRATION

Issue Date: December 23, 2022

Effective Date: January 23, 2023

On November 23, 2022, the Staff of the Public Service Commission (Staff) filed a motion advising the Commission to cancel the Interconnected Voice over Internet Protocol (IVolP) registration of Crosstalk Solutions, LLC (Company) at that company's request. The Company also filed a letter with the Commission on November 2, in Tracking No. BCES 2023-0265, requesting the Commission to cancel its authority to provide VoIP services in the State of Missouri. The Commission granted the Company its registration in File No. DA-2021-0172 on January 1, 2021.

The Commission issued its order establishing time to respond to Staff's motion, directing anyone wishing to respond to Staff's recommendation or request a hearing to do so by filing an appropriate pleading no later than December 9, 2022. No responses were received by the Commission.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the Company's request, the Commission finds that the registration granted to the Company shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVolP services granted to Crosstalk Solutions, LLC in File Number DA-2021-0172, is canceled.
2. This order shall become effective on January 23, 2023.
3. This file may be closed on January 24, 2023.
