ORDER GRANTING CONTINUANCE

On June 20, 2016, the Commission issued an order setting a procedural conference in this matter for June 30, 2016. On June 26, 2016, Union Electric Company d/b/a Ameren Missouri filed a *Motion for Continuance*, stating that its counsel would be unavailable on June 30 and other dates in July and requesting that the procedural conference be re-scheduled for the first part of August. The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's *Motion for Continuance* is granted. The procedural conference previously scheduled for June 30, 2016, is canceled.
2. A procedural conference shall be held on August 10, 2016, beginning at 2:00 p.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional accommodations to
