REPLY OF GREAT PLAINS ENERGY INCORPORATED TO STAFF'S RESPONSE TO SECOND COMMISSION ORDER

Comes now Great Plains Energy Incorporated ("GPE"), and respectfully submits this Reply to the Staff's Response to Second Commission Order (the "Second Staff Response") in this case.

- 1. GPE's application in this case recited a Securities and Exchange Commission ("SEC") requirement, under the Public Utility Holding Company Act (the "Act"), to file quarterly reports on Form U-9C-3 with the state commissions having jurisdiction over Kansas City Power & Light Company.
- 2. Pursuant to the Commission's March 20, 2002, Order Directing Filing, Staff filed a response on April 19, 2002 ("First Staff Response"), recommending that GPE be ordered to timely submit to the Director of the Utility Services Division a copy of all future Form U-9C-3 filings in lieu of formal filings with the Commission.
- 3. GPE filed a reply to the First Staff Response, indicating that it was willing to continue formal filings in this case, and would also accept the Staff's recommendation to submit copies of these quarterly reports to the Director of the Utility Services Division in lieu of formal filings.

- 4. The Second Staff Response continues Staff's recommendation that copies of the quarterly reports be submitted to the Director of the Utility Services Division in lieu of formal filings. The Second Staff Response also indicates that if the Commissioners wish to continue to individually receive copies of these reports, GPE should be directed to continue to make formal filings.
- 5. As GPE indicated in its reply to the First Staff Response, it is certainly willing to continue formal filings of its Form U-9C-3 reports in this case, under the Commission's protective order issued in this case. If the Commission does not wish to keep this case open, GPE will also accept, as the Staff recommends, a Commission order directing GPE to timely submit to the Director of the Utility Services Division of the Commission a copy of all future Form U-9C-3 filings made by GPE. GPE notes that Section 386.480, RSMo, would be applicable to those submissions, and is consistent with the confidential filing of quarterly reports on Form U-9C-3 with the SEC.
