**PUBLIC COUNSEL'S SUBSTITUTE FILING**

COMES NOW the Office of the Public Counsel for its Substitute Filing states as follows:

1. On June 23, 2011, Public counsel filed two documents in this case: a review and general discussion of Ameren Missouri's resource plan; and a list of deficiencies and proposed remedies. The Ameren Missouri workpapers on which parts of both documents were based were marked as Highly Confidential, so Public Counsel marked each page of each document as Highly Confidential.

2. On June 24, Ameren Missouri informed Public Counsel that none of the information in the reports was in fact Highly Confidential (see Attachment 1 hereto). Public Counsel requested that the Commission's Data Center re-classify the documents as Public rather than Highly Confidential, and the re-classification was subsequently made. The documents, although now publicly accessible, are still marked Highly Confidential on each page.

3. 4 CSR 240-2.080(20) provides that: "Any pleading may be amended within ten (10) days of filing, unless a responsive pleading has already been filed, or at anytime by leave of the commission." This filing is made within ten days of the original filing and no responsive pleadings have been filed. Public Counsel hereby amends the original filing by substituting the accompanying reports, which are identical to the reports filed on June 23 except that the Highly Confidential designation has been removed.

WHEREFORE, Public Counsel respectfully amends the two reports filed on June 23 by substituting the reports accompanying this filing.
