

3. Buyers d/b/a UCN's certificate of authority to do business from the Missouri secretary of state was provided in Case No. XA-2003-0554. Pursuant to 4 CSR 240-2.060(G), Buyers d/b/a UCN requests that the certificate and registration be incorporated by reference herein.

4. Buyers d/b/a UCN is the second of two entities licensed by the Commission to provide interexchange and nonswitched local exchange telecommunications services. The other is Buyers United, d/b/a buyersonline, which obtained its license in Case No. XN-2003-0450.

5. A corporate name change was approved by Buyers United, Inc.'s Board of Directors and became effective July 15, 2004. The new name of the company is UCN, Inc.

6. UCN, Inc. (f/k/a Buyers United) notified its customers of the name change and filed paperwork with the Secretary of State ("SoS") to amend its Certificate of Authority to transact business in Missouri. The SoS approved the amendment on August 23, 2004.

7. On September 21, 2004, UCN, Inc. (f/k/a Buyers United) filed an Application for Recognition of Name Change and Approval of Tariff Revisions in order to change the name on the first of its Certificates of Service Authority from Buyers United, Inc., d/b/a buyersonline to UCN, Inc. The Application was filed in relation to Case No. XN-2003-0450.

8. Upon approval of the name change, UCN, Inc. will no longer require two separate Certificates of Service Authority in Missouri. The only reason two separate licenses were obtained in the first instance was due to Commission rules limiting a carrier's ability to operate with more than one fictitious name pursuant to a single license. The second license issued to Buyers d/b/a UCN is now unnecessary.

9. Wherefore, UCN, Inc. (f/k/a Buyers United) respectfully requests cancellation of the Certificate of Service Authority issued in Case No. XA-2003-0554 and cancellation of the tariff in File No. YX-2003-2187

10. Buyers d/b/a UCN does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years

of the date of the application. Buyers d/b/a UCN does not, to the best of its knowledge, have any overdue annual reports or assessment fees.



12. Cancellation of Buyers d/b/a UCN's Certificate of Service Authority and tariff is not detrimental to the public interest. The public will not be harmed by Buyers d/b/a UCN's withdrawal because, as stated above, UCN, Inc., the corporate entity responsible for providing telecommunications services, will retain the Commission authority issued in Case No. XN-2003-0450 to continue providing services.

WHEREFORE, Buyers d/b/a UCN respectfully requests the Commission to issue an order canceling its certificate of service authority and tariff and granting such other relief as is reasonable in the circumstances.

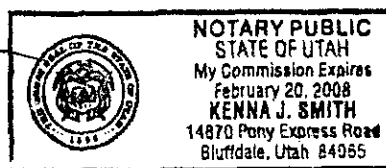


