On January 27, 2022, Momentum Telecom, Inc. pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol services in the following exchanges:

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. 3. This order shall become effective on February 14, 2022.
