## COMPLIANCE FILING OF KANSAS CITY POWER & LIGHT COMPANY CONCERNING RATE CASE CUSTOMER NOTICE BILLING INSERT

Pursuant to the July 6, 2006 order of the Public Service Commission of the State of Missouri ("Commission") in the above-captioned case and 4 CSR 240-2.080, Kansas City Power & Light Company ("KCPL") hereby notifies the Commission that KCPL included a notice of rate proceeding in its bills to its customers as directed by the Commission. In support hereof, KCPL offers as follows:

- 1. On February 1, 2006, KCPL submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. On February 3, 2006, the Commission ordered the Office of the Public Counsel ("OPC") to submit a proposed customer notice no later than March 28, 2006. The Commission allowed parties until April 4, 2006 to object to OPC's proposed notice. OPC filed its proposed customer notice on March 28, 2006. No party objected.
- 2. On July 6, 2006, the Commission issued an order directing KCPL to send its customers notice of the proposed rate increase and the local public hearings as proposed by OPC. The Commission directed KCPL to include such notice as a billing insert that would arrive at each customer's mailing address no later than August 14, 2006.
- 3. KCPL began including the attached customer notice insert in its customers' bills beginning July 14, 2006. Due to the timing of KCPL's billing cycles, KCPL will continue

mailing out bills with the notice until August 11, 2006, at which point KCPL will have sent the

notice to all of its customers. KCPL also posted the notice on its AccountLink website to ensure

that its paperless billing customers also received the notice.

4. Barring some unforeseen postal delay, KCPL fully anticipates that all of its

customers will have received the insert by the August 14, 2006 deadline prescribed by the

Commission in its July 6 order.
