In addition, the affidavit attached to the application failed to provide the exchanges in which the company proposes to provide VoIP service, pursuant to §392.550.3(2), RSMo Cum. Supp. 2011.

The Commission will not take action on this application until these deficiencies are corrected. The Commission will leave the file open until December 28, 2012, to allow Intermedia to correct the deficiencies. If no response is filed by that time, the

Commission will reject the application and close the file.


