- Item No. 6 of page 2 of your annual report identifies a positive amount, however the MoUSF assessment was suspended in 2022. It appears the report mistakenly contains the Relay Remittance for 2022 in this box.
- Page 2 entries all seem to have typed information on top of typed information which is hard to read.

Please resubmit your revised annual report in its entirety to correct the deficiency. Any revised annual report/response must be filed within the Missouri Commission's Electronic Filing and Information System (EFIS) using the identification number(s) in the subject of this email.
