ORDER DIRECTING CORRECTED NOTICE AND EXTENDING DATE
FOR SUBMISSION OF INTERVENTION REQUESTS

On September 12, 2007, the Commission issued an Order Directing Notice, Setting Date for Submission of Intervention Requests, and Scheduling a Prehearing Conference. As part of that order, the Commission directed its Data Center to mail a copy of that notice to each of the parties in The Empire District Electric Company's most recent rate case, which the order identified as Case Number ER-2006-0314. The Data Center complied with that order by providing notice to the parties in ER-2006-0314.

Unfortunately, Case Number ER-2006-0314 was a rate case for Kansas City Power & Light, not Empire. The correct case number for Empire's most recent rate case is ER-2006-0315. Because of the error in the Commission's order, the Data Center mailed the notice to the wrong parties.

To correct this mistake, the Commission will direct its Data Center to mail a copy of this order and the September 12 Order Directing Notice, Setting Date for Submission of Intervention Requests, and Scheduling a Prehearing Conference to the parties in Case Number ER-2006-0315. To allow time for the filing of requests to intervene from parties

that will be receiving this corrected notice, the Commission will also extend the deadline for filing requests to intervene.

IT IS ORDERED THAT:

1. The Missouri Public Service Commission's Data Center shall mail a copy of this order, as well as the Order Directing Notice, Setting Date for Submission of Intervention Requests, and Scheduling a Prehearing Conference, which it issued on September 12, to each of the parties in The Empire District Electric Company's most recent rate case, ER-2006-0315.

2. Any proper person wishing to intervene in this matter shall file an application to intervene no later than October 17, 2007. Such applications shall be filed with:
