**Necessity for Highly Confidential Treatment 2009 Annual Report**


In support of Navigator's position of Confidentiality, the Company claims that this information is sensitive commercial, financial, and competitive information that could cause substantial harm to our financial and competitive position not just in Missouri but in other states in which Navigator has operations. Navigator is a small, privately held company, and does not publicly disclose sensitive financial information. As a competitive provider in numerous states, Navigator provides services in direct competition with other incumbent and competitive providers, many of whom are certified and operating in the State of Missouri. Release of Highly Confidential financial information could seriously hamper our ability to remain viable in any of our current service territories. Any time such information is provided per state commission request, Navigator always requests that such information be treated in a confidential manner and that the requested information not be subject to public disclosure.

The information in which a Highly Confidential designation is being requested includes the Missouri Jurisdictional and Total Company Revenues for 2009 (Form Page 3), Line Quantities for Local Voice Service and IVolP Service for 2009 (Form Page 5), and Relay Missouri Annual Billing, Collections and Retention for 2009 (Form Page 6).
