Calvin Craib, being first duly sworn on oath, deposes and states as follows:

1. MCC Telephony of Missouri, Inc. ("MCC") is a facilities-based competitive local exchange carrier certified in the State of Missouri. MCC has offices located at 100 Crystal Run Road, Middletown, NY 10941.

2. I am the President of MCC, and in this capacity I have personal knowledge of all relevant matters pertaining to this request and I am authorized to make this affidavit on behalf of the MCC.

3. MCC is requesting confidential treatment for the portion of its 2007 Annual Report seeking disclosure of MCC's Revenues (page 3) and Access Line Provided by customer type (pages 4, 5(a) and 5(b)).

4. The information for which MCC seeks confidential treatment is proprietary and comprises trade secret information that would aid competitors of MCC and therefore is protectible from disclosure pursuant to Missouri law.

5. The information for which protection is sought includes MCC's Financial Data, which is not available to MCC's competitors from any other source. As a non-public subsidiary of a publicly held company, MCC's Financial Data is not reported separately to the Securities Exchange Commission; is not otherwise publicly available to MCC's competitors; and MCC takes reasonable precautions to maintain and protect the confidentiality of such information.

6. The information for which protection is sought also includes MCC's number of subscribers and number of access lines. This information is treated by MCC as confidential and proprietary, and is protected internally by MCC as proprietary information.

7. The information for which protection is sought is proprietary information that would aid competitors of MCC and therefore is protectible from disclosure and is information which comprises trade secrets protectible from public disclosure.
