NOTICE OF WITHDRAWAL OF TARIFF OBJECTIONS

AT&T¹ wishes to notify the Commission that with the filing of YMax's revised tariff sheets on September 9, 2012, AT&T withdraws its Motion to Suspend and Investigate Tariff²

AT&T's withdrawal of its objections to the proposed tariff revisions, however, is not to be construed as agreement or acquiescence in any billing practices under YMax's current or revised tariffs through which it would bill end office charges. As explained in AT&T's Motion to Suspend, the FCC has unequivocally ruled that its "rules do not permit a LEC to charge for functions performed neither by itself or its retail [VoIP] service provider partner." Here, YMax does not provide any end office switching or any part of a local loop or a physical connection that can constitute end office functions for which it can charge. YMax therefore should not bill AT&T or any other interexchange carrier for those services. In the event YMax continues to bill such charges, AT&T will continue to dispute and withhold payment of these unlawfully imposed charges and reserves the right to avail itself of all available remedies.
