

## Dear Customer:

After implementing professional operations and investing almost \$2,000,000 in improving water and wastewater infrastructure in your community, Elm Hills Utility Operating Company (Elm Hills) is working to ensure you have access to clean, safe and reliable drinking water and wastewater systems.

As a result, in early March Elm Hills submitted a request to the Missouri Public Service Commission (PSC) for an increase in its annual water operating revenues of \$135,745.45 and an increase in its annual sewer operating revenues of \$393,919.34. At the end of this notice is a table that compares the Company's current residential customer rates and the proposed residential rates. The PSC is the state agency that will ultimately rule on this request.

These improvements to the systems that carry the water you drink include remote monitoring equipment at each location to assure facilities are closely tracked and work properly at all times; chlorination equipment and analyzers; repair of storage tanks; and new booster pumps. Our improvements to your wastewater facilities include basic system repairs at each location, remote flow monitoring, plant improvements to ensure removal of ammonia, a toxic pollutant, to comply with Missouri Department of Natural Resources and EPA regulations, plus structural improvements where needed.

With the recent spread of the COVID-19 virus, the associated restrictions on public gatherings, and other recommended social distancing measures, it is currently not known when, or if, the PSC will hold Local Public Hearings where you can voice your comments. However, you do have the opportunity to provide comments to the PSC and Office of Public Counsel regarding Elm Hills' request or regarding service-related issues. We highly encourage you to do so. Your comments should include a reference to case number WR-2020-0275. The Public Commission Staff and the Public Counsel will review all customer comments submitted in response to this notice. All comments will be filed in the official case file for review by the commissioners.
