ORDER GIVING NOTICE OF CONTESTED CASE, DIRECTING RESPONDENT TO FILE ANSWER, AND DIRECTING STAFF INVESTIGATION

Issue Date: March 16, 2016 Effective Date: March 16, 2016

On March 15, 2016, James and Angela Dickson (hereinafter, Complainants or "Dicksons") filed a formal complaint with the Missouri Public Service Commission seeking relief against Kansas City Power and Light Company ("KCP&L"), a public utility regulated by the Commission. Although Complainants also name KC Water Services as a respondent, the Commission lacks jurisdiction over the municipally owned water system.¹

A copy of the complaint accompanies this notice. This is a contested case² pursuant to section 386.390, RSMo 2000. The Commission will set a 30-day deadline for KCP&L to file an answer. In the alternative, KCP&L may file a written request that the complaint be referred to a neutral third-party mediator for voluntary mediation.

² A "'[c]ontested case' means a proceeding before an agency in which legal rights, duties or privileges of specific parties are required by law to be determined after hearing." Section 536.010.4, RSMo (Cum.Supp. 2013).

Upon receipt of requests for mediation, the 30-day time period shall be tolled

while the Commission ascertains whether the Dicksons are also willing to submit to

voluntary mediation. If the Dicksons agrees to mediation, the time within which answers

are due shall be suspended pending the resolution of mediation. Additional information

regarding the mediation process is enclosed. If the Dicksons decline to mediate the

dispute, KCP&L will be notified in writing that the tolling has ceased and will also be

notified of the date by which answers must be filed. That period is usually the remainder

of the original 30-day period.

As required by section 536.067(2)(f), RSMo 2000, the Commission informs the

parties that the Commission's provisions governing procedures before the Commission,

including provisions relating to discovery, are found at Commission rule 4 CSR 240-

2.090. The Commission will also set a deadline for its Staff to file a report on the

complaint.

On March 16, Robert Hack and Roger Steiner entered their appearance on

behalf of KCP&L. Since counsels for KCP&L have entered their appearance, the

Commission will forego mailing notice of this order and the Dickson's complaint to

Respondent.

THE COMMISSION ORDERS THAT:

- 2. KCP&L shall file an answer to the complaint or request mediation no later than April 15, 2016. All pleadings (the answer, the notice of satisfaction of complaint, or request for mediation) shall be filed using the Commission's Electronic Filing and Information System ("EFIS") or by mail to the Secretary of the Commission.
- 3. The Staff of the Missouri Public Service Commission shall file a report with the Commission no later than April 28, 2016.
 - 4. This order shall be effective when issued.
