## ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING RECOMMENDATIONS, SETTING DATE FOR SUBMISSION OF INTERVENTION REQUESTS AND SETTING DATE FOR FILING A PROCEDURAL SCHEDULE

On June 22, 2006, the Staff of the Missouri Public Service Commission filed a motion requesting that the Commission establish a case, provide notice, set an intervention deadline and schedule an early prehearing conference for the purpose of establishing a record of consideration and a determination as to whether to adopt the Fossil Fuel Generation Efficiency Standard established in Section 1251 of the Energy Policy Act of 2005 ("EPAct"). Pursuant to EPAct, the Commission is required to commence consideration of this standard no later than August 8, 2007, and is further required to make a determination no later than August 8, 2008.

EPAct amended various portions of the Public Utility Regulatory Policies Act of 1978 ("PURPA"). EPAct incorporated five new standards in PURPA section 111(d), i.e. PURPA section 111(d)(11)-(15). In order to comply with EPAct, the Commission

must consider and determine whether to adopt each of the new section 111(d) standards with respect to each electrical utility.

Upon review of the application, the Commission finds that the motion should be granted to establish a case, and that notice should be sent to interested persons and an intervention date set. The Commission will direct Staff, the Office of the Public Counsel and all proper parties to jointly file a proposed procedural schedule.

The Commission determines that notice of this action should be given by the Commission's Data Center sending a copy of this order to all of the electrical utilities in the state of Missouri, to the Department of Natural Resources of the State of Missouri, and to all other persons listed in Appendix A of Staff's Motion. The Commission further determines that the information officer of the Commission should provide notice to all members of the General Assembly. Staff will be directed to file a recommendation as to if any other entities should receive notice of this action.

The Commission finds that proper persons wishing to intervene shall have thirty (30) days from the date of this order to file an application to intervene with the Secretary of the Commission and shall send a copy of the application to intervene to all parties as directed below.

An early prehearing conference will also be scheduled, and will be held simultaneously with the prehearing conference set for cases EO-2006-0493, EO-2006-0494, EO-2006-0496, and EO-2006-0497, addressing other new PURPA section 111(d) standards. The Commission will also require the parties to file a proposed procedural schedule that provides for a hearing if requested.

IT IS ORDERED THAT:

1. The Staff of the Missouri Public Service Commission's motion to open a

case is granted.

2. The Missouri Public Service Commission's Data Center is ordered to

serve notice as set out herein.

3. The Missouri Public Service Commission's information officer is ordered

to serve notice as set out herein.

4. Staff is ordered to submit a recommendation as to if any other party

should be notified about this action no later than June 28, 2006.
