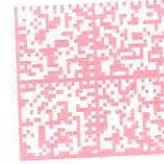

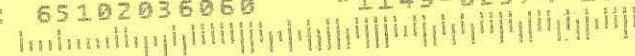

THE COMMISSION ORDERS THAT:


1. The Commission recognizes the name change of TWC Digital Phone, LLC to Spectrum Advanced Services, LLC.


