On January 23, 2008, Kansas City Power & Light Company filed an Application for Waiver or Variance Concerning Certain All-Electric and Electric Heating Customers of Kansas City Power & Light Company. KCPL asks the Commission for a waiver or variance of portions of the Report and Order in Case No. ER-2007-0291 as those portions pertain to KCPL's general service all-electric tariffs and separately-metered space heating rates for customers not taking service under those rates as of January 1, 2008, but who committed financial resources based upon their expectation that those rates would be available.
