**ORDER CANCELING CERTIFICATE  
AND ACCOMPANYING TARIFF**

Issue Date: June 30, 2009

Effective Date: July 11, 2009

On June 4, 2009, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission cancel the certificate of service authority and accompanying tariff of Reliant Communications, Inc., f/k/a HJN Telecom, Inc. to provide basic local telecommunications services in Missouri.

In File Number TA-2000-0217, the Commission granted HJN Telecom, Inc. a certificate of service authority to provide basic local exchange telecommunications services. HJN's tariff, P.S.C. MO Tariff No. 2, was also approved.

On December 5, 2002, the Commission issued an Order in File No. CN-2003-0174, recognizing the name change of HJN to Reliant Communications, Inc. and approving the adoption of HJN's tariff.

Staff's motion states that Reliant requested the certificate be withdrawn as the CLEC operations of Reliant have been dormant. Staff further states Reliant is no longer providing competitive local services in Missouri and has no past assessments or annual reports due to the Commission. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Reliant’s request and Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Reliant Communications Inc. shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority to provide basic local telecommunications services in Missouri, granted to Reliant Communications, Inc. f/k/a HJN Telecom, Inc. in File Number TA-2000-0217, is canceled.
2. Reliant Communications, Inc.’s tariff, P.S.C. MO No. 2, is canceled
3. This order shall become effective on July 11, 2009.
4. This case may be closed on July 12, 2009.
