ORDER ESTABLISHING TIME TO RESPOND

On March 28, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificate of the Cathect Communications to provide basic local exchange telecommunications service. The Commission granted Cathect Communications a certificate to provide basic local exchange telecommunications service in File No. CA-2021-0268.

The requirements of telecommunication companies include filing an annual report and a Statement of Revenue, which Staff's motion states was not filed by Cathect Communications. Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate and IVoIP registration based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

- 1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 7, 2023.
 - 2. This order shall be effective when issued.
