

APPLICATION

COMES NOW EliteView, LLC d/b/a GroveLine (“Applicant”), and applies to the Public Service Commission of Missouri for a Certificate of Service Authority to provide competitive intrastate interexchange telecommunications services and non-switched local exchange service between and among locations within the state of Missouri, pursuant to Section 392.440 RSMo 2000.¹ Applicant further applies to be classified as a competitive telecommunications carrier, subject to the waiver or suspension of certain Commission rules and statutory provisions pursuant to Sections 392.420 and 392.440, as requested herein. In support of its request, Applicant provides the following information:

2. **Corporate Information. 4 CSR 240-2.060**

Applicant is a privately-held limited liability corporation organized under the laws of the Commonwealth of Massachusetts on June 30, 2000. A copy of Applicant's Certificate of Authority to Transact Business in Missouri and Fictitious Name Registration are attached hereto as **Exhibit A** and incorporated herein by reference.

Applicant's statutory representation in the state of Missouri is:

3. **Description of Applicant and Proposed Services to be Offered in Missouri.**

Applicant is a non-facilities based provider of resold competitive intra and interstate interexchange telecommunications services. Applicant proposes to provide resold, switched and dedicated 1+, toll-free, post-paid calling card, data and frame relay interexchange telecommunications services throughout the State of Missouri, primarily to business customers. Applicant will not provide non-switched service within an exchange. Applicant will provide directory and operator assistance exclusively to subscribers of record. Application does not propose to provide alternative operator services to the transient public.

Applicant's tariff, containing the rules and regulations applicable to its customers, a description of the services offered, and a list of rates associated with such services, in

accordance with Commission regulations, is being filed contemporaneously with this application. Applicant's proposed tariff has a forty-five (45) day effective date.

4. **Statement of Managerial Ability**

Applicant possesses extensive telecommunications and business experience to provide quality, continuous resold interexchange telecommunications services in the State of Missouri. Applicant's senior management team has long standing corporate, financial, telecommunications, network, and customer and carrier relations experience. Applicant's key managers have been with the Company since its inception in 2001.

5. **Statement of Financial Viability**

Applicant has the financial viability to provide interexchange telecommunications services in the State of Missouri. Applicant is fully funded and requires no external funding. As a non-facilities-based provider of telecommunications services, Applicant's liabilities are incurred upon the rendering of service, and directly attributable to Applicant's subscribers. Applicant does not plan to construct facilities, and will, therefore, require no additional capitalization nor resource expenditure to expand its operations in Missouri.

6. **Request for Competitive Telecommunications Company and Service Classification. 4 CSR 240-2.060 (6) (A)**

Applicant requests classification as a competitive telecommunications company operating within the state of Missouri. Applicant further requests classification of its services described in paragraph 3, Supra, and in its proposed tariff, as competitive services.

Applicant will not unjustly discriminate among its customers, which discrimination is prohibited pursuant to Section 392.200 RSMo.

Pursuant to Section 386.570 RSMo, Applicant will comply with all applicable Commission rules, except those that are specifically waived by the Commission pursuant to a request filed by the Applicant.

Applicant does not provide alternative operator services.

7. Request for Waiver and Exemption. 392.420 RSMo

Pursuant to Section 392.420 RSMo, Applicant further respectfully requests, that the Commission suspend, waive, or exempt application of the following rules and statutory provisions as they relate to the regulation of Applicant as a competitive interexchange telecommunications service provider:

The above-referenced rules and statutory provisions have been waived by the Commission for other competitive interexchange carriers in prior cases. The rules and statutory provisions for which Applicant seeks waiver or exemption are principally

applicable to non-competitive telecommunications carriers. It would be inconsistent with the goal and purpose of Section 392.530 RSMo to apply such rules or statutory provisions to a competitive telecommunications carrier such as Applicant.

9. **Annual Report or Assessment Statement. 4 CSR 240-2.060 (1) (L)**

Applicant has no annual reports or regulatory assessment fees that are overdue in Missouri.

10. **Pending Action or Unsatisfied Judgments Statement. 4 CSR 240-2.060 (1) (K)**

Applicant has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment, or decision has occurred within three (3) years of the date of this application.

11. **Public Interest Statement. 392.430**

Applicant submits that the public interest will be served by Commission approval of the instant application because the proposed services will create and enhance competition and expand customer service options consistent with the legislative goals set forth in the Federal Telecommunications Act of 1996, and Chapter 392, RSMo 2000. Prompt approval of Applicant's application will further expand the availability of innovative, high quality, and reliable telecommunications services within the state of Missouri.

WHEREFORE, Applicant, EliteView, LLC d/b/a GroveLine, respectfully requests the Missouri Public Service Commission to grant it a Certificate of Service Authority to provide competitive intrastate interexchange telecommunications services within the state of Missouri; an order classifying it as a competitive telecommunications company providing competitive service; an order suspending, waiving, or modifying the above-referenced rules and statutory provisions as they relate to the regulation of the Applicant in the state of Missouri; and for such further orders as the Commission deems appropriate.

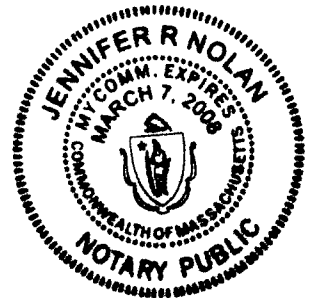

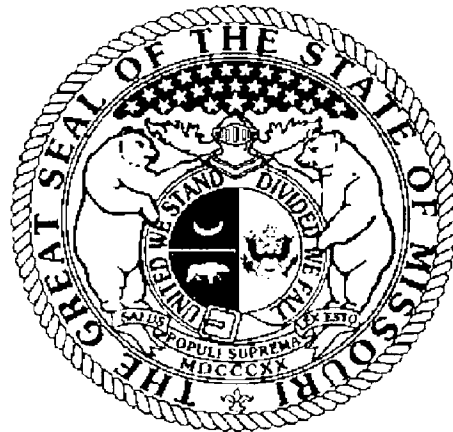
