ORDER CANCELING SERVICE AUTHORITY

On August 10, 2022, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the registration of interconnected voice over internet protocol (IVoIP) service authority of ConvergeOne Unified Technology Solutions, Inc. (Company). On August 30, 2018, the Commission granted a registration to the Company to provide IVoIP services in File No. DA-2019-0057. Staff's motion states that the Company requested the Commission to cancel the IVoIP authorization of the Company.

On August 11, 2022, the Commission issued its order that anyone wishing to respond to Staff's motion or request a hearing do so by filing a pleading no later than August 22, 2022. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, the Commission may cancel the certificate based on Staff's motion.

THE COMMISSION ORDERS THAT:

- The IVoIP service authority of ConvergeOne Unified Technology Solutions,
 Inc. is canceled.
