ORDER ESTABLISHING TIME TO RESPOND

On March 23, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the registration to provide interconnected voice over internet protocol (IVoIP) service of YTEL, Inc. The Commission granted YTEL, Inc. registration to provide IVoIP service in File No. DA-2019-0219.

Subsection 392.550(6), RSMo, provides that the Commission may revoke an IVoIP registration for failure to comply with the requirements of Section 392.550, RSMo. The requirements include filing an annual report, a Statement of Revenue report, and paying the Missouri Commission assessment.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the registration based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 3, 2023.
2. This order shall be effective when issued.

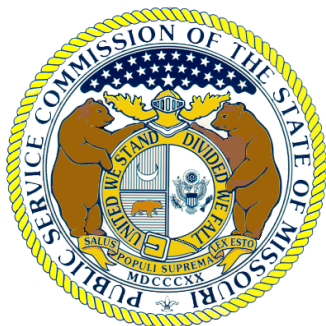
