RE: Aero Communications, LLC - Request for Relinquishment of Certificates of Service Authority to Provide Interexchange and Basic Local Telecommunications Services

Dear Mr. Woodruff:

Pursuant to 20 CSR § 4240-28.011(3), Aero Communications, LLC ("Aero") wishes to terminate its authority as a telecommunications services provider in the state of Missouri. Specifically, seeks to relinquish its Certificates of Service Authority to provide interexchange and basic local telecommunications services in Missouri. A Certificate of Service Authority to provide interexchange and non-switched local exchange carrier was issued on February 9, 2006 in Case No. XA-2006-0277. A Certificate of Service Authority to provide basic local telecommunications services was issued on January 13, 2006 in Case No. CA-2006-0255. Aero used these licenses primarily to provide secure data and voice services to banks and other financial institutions. However, Aero's business model changed and it has not served any customers in the state since 2015.

Aero also requests cancellation of its tariffs on file with the Commission, including its tariff for interexchange eservices with tracking number YX-2006-0514. Aero has no active customers in Missouri so there will be no impact on customers. Aero has filed its annual report for 2021 and it will be its final report. Aero will pay any required assessment. There are no outstanding liens against its operating authority or any fines owed to the Commission.

Aero requests that this relinquishment of Certificates of Service Authority be effective immediately. Please contact me if additional information is required or if there are any questions.
