AMENDMENT BY INTERLINEATION TO APPLICATION FOR A CERTIFICATE OF SERVICE AUTHORITY AND FOR COMPETITIVE CLASSIFICATION

Comes now Davidson Telecom, L.L.C ("Davidson Telecom", "Applicant" or "Company") and pursuant to 4 CSR 240-2.080(14) hereby files this amendment by interlineation to its Application for a Certificate of Service Authority (the Application) in the captioned matter as set forth below.

1. In several portions of the application, the recent transaction between GTE of the Midwest, Inc. d/b/a Verizon and CenturyTel was overlooked. As a consequence, Paragraph 6 of the Application is amended and shall hereafter read in full as follows:

By this Application, Davidson Telecom seeks to provide facilities-based and resold local telecommunications services throughout the exchanges currently served by SWBT, CenturyTel, Sprint and Spectra. The exchanges in which Davidson Telecom seeks authority are listed in approved tariffs of SWBT, Century Tel, Sprint and Spectra. Pursuant to applicable law, and subject to Davidson Telecom's right under federal and state laws to seek to offer and provide service in geographical areas smaller than an exchange or in market segmentations or to offer customer-specific pricing, similarly situated subscribers located within the listed exchanges will receive services on equal terms and conditions as set forth in Davidson Telecom's tariffs.

2. Paragraph 19 is also amended for the same reasons explained above and shall hereinafter read in full as follows:

Davidson Telecom further requests a temporary waiver of 4 CSR § 240-2.060(6)(C). This rule requires that an application for a certificate of service authority to provide basic local exchange services shall include a proposed tariff with a forty-five (45) day effective date. Davidson Telecom finds it impossible at this time to develop tariffs to fully comply with this rule since interconnection agreements with SWBT, CenturyTel, Sprint and Spectra have not been fully negotiated. At such time as all facts necessary for the development of such tariffs are known to Davidson Telecom, the Company promptly will file said tariffs with the Commission in a manner consistent with recent Commission practice in similar cases. All filed tariffs will bear no less than a forty-five (45) day effective date. Once signed, all interconnection agreements with incumbent local exchange carriers also will be submitted for the Commission's approval.

- 3. In further amendment, and in supplementation, of its application, Telecom Davidson offer Davidson states that Telecom will basic telecommunications service as a separate and distinct service pursuant to Section 392.455(4) RSMo. 2000. Davidson Telecom will provide equitable access, as determined by the Commission, for all Missourians within the geographic area in which it will offer basic local services in compliance with Section 392.455(5), RSMo 2000.
- 4. Except as set forth above, the remainder of the Application is unaltered by this amendment.

WHEREFORE, on the basis of the Application as amended and supplemented, Davidson Telecom respectfully requests that the Commission grant it a Certificate of Service Authority to provide competitive facilities-based and resold basic local exchange services throughout the State of Missouri as described in this Application; classify it as a competitive telecommunications company in Missouri and grant waivers of the aforementioned rules and statutory provisions.
