APPLICATION FOR THE CANCELLATION OF CERTIFICATE OF SERVICE AUTHORITY AND WITHDRAWAL OF TARIFF(S)

COMES NOW Zayo Group, LLC ("Zayo"), as the successor in interest to American Fiber Systems, Inc. ("AFS") (together, the "Company"), pursuant to Section 392.410.5 RSMo and the Rules of the Missouri Public Service Commission ("Commission"), and hereby requests the Commission cancel the Certificate of Service Authority ("CSA") of AFS as well as any approved tariff. In support of its request, the Company states the following:

1. AFS was a Delaware corporation and a wholly-owned indirect subsidiary of Zayo. The Company's principal place of business is 400 Centennial Parkway, Suite 200, Louisville, Colorado 80027. On March 12, 2013, the Company completed the *Pro Forma* Transactions described in the Company's Notification filed on December 31, 2012 and assigned BNIR-2013-0364. As a result, AFS no longer exists as a separate corporate entity. Therefore, the Company is not providing a copy of a Certificate of Authority to Transact Business or Certificate of Good Standing for AFS.

4. In Missouri, AFS is authorized to provide non-switched local and interexchange services pursuant to a CSA granted Case No. TA-2001-0258.

5. As a result of the *Pro Forma* Transactions, AFS does not exist as a separate corporate entity and Zayo provides service to AFS's customers. AFS, therefore, no longer requires its CSA and the Company respectfully submits that the surrender and cancellation of AFS's CSA and withdrawal of its tariff(s) are reasonable and necessary.

6. The Company states that, to the best of its knowledge, (1) there are no annual reports or assessment fees that are overdue for AFS in Missouri and (2) AFS does not have any

pending action or unsatisfied final judgments or decisions against it in any state, federal agency or court which involves customers service or rates, which has occurred within three years of this Application.

7. The Commission has the authority to cancel a CSA pursuant to Section 392.410.5 RSMo (Cum. Supp. 2012), which provides that:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.

WHEREFORE, the Company respectfully requests that the Commission grant this Application and cancel the Certificate of Service Authority of American Fiber Systems, Inc. and withdraw its approved tariff(s) on file, together with such other and further relief as is necessary or convenient to affording the relief herein requested.
