ORDER DISMISSING APPLICATIONS

Effective Date: March 3, 2023

On August 8 through August 10, 2022, fifteen (15) individuals or couples

(Applicants) filed a request for a change of electric supplier from the City of Butler,

Missouri ("City of Butler") to the Osage Valley Electric Cooperative Association ("Osage

Valley").

On October 5, City of Butler and Osage Valley filed their Joint Application for approval of a territorial agreement in File No. EO-2023-0126. That territorial agreement purports to assign the right to provide electric service to all of the Applicants herein mentioned to City of Butler and will eliminate the concerns about the legality of the service provided by the City of Butler that led the Applicants to request a change of supplier. The Commission issued an order in that case directing the Commission's Data Center to send a copy of the Joint Application in that matter to all applicants in these cases on October 7, 2022.

On December 20, 2022, the Commission issued an order directing the Applicants to file a response, no later than January 13, 2023, stating whether they wish to proceed with their application for change of electric supplier or dismiss their application in light of the pending territorial agreement submitted by City of Butler and Osage Valley in File No. EO-2023-0126. The Commission received no responses to that order.

The Commission may dismiss a case for good cause found by the Commission after a minimum of ten days notice to all parties involved pursuant to 20 CSR 4240-2.116(4).

The Commission will approve the submitted territorial agreement in a separate order. The approved agreement appears to address the concerns expressed by the Applicants and none of the Applicants have indicated a desire to further pursue their applications. The Commission will dismiss File Numbers EO-2023-0039, EO-2023-0040, EO-2023-0041, EO-2023-0042, EO-2023-0043, EO-2023-0044, EO-2023-0045, EO-2023-0046, EO-2023-0047, EO-2023-0048, EO-2023-0049, EO-2023-0050,

EO-2023-0051, EO-2023-0063, and EO-2023-0064, for good cause, pursuant to 20 CSR 4240-2.116(4).

THE COMMISSION ORDERS THAT:

1. File No's. EO-2023-0039, EO-2023-0040, EO-2023-0041, EO-2023-0042, EO-2023-0043, EO-2023-0044, EO-2023-0045, EO-2023-0046, EO-2023-0047, EO-2023-0048, EO-2023-0049, EO-2023-0050, EO-2023-0051, EO-2023-0063, and EO-2023-0064, are dismissed.
