**ORDER DIRECTING NOTICE AND SETTING INTERVENTION DEADLINE**

On October 12, 2016, Great Plains Energy Incorporated (GPE), Kansas City Power & Light Company (KCP&L), and KCP&L Greater Missouri Operations Company (GMO) (collectively, the Joint Applicants) filed an application with the Missouri Public Service Commission seeking a limited variance or waiver from Commission Rule 4 CSR 240-20.015 regarding certain affiliate transactions that will occur between the KCP&L, GMO, and Westar operating companies after GPE completes its merger with Westar Energy, Inc. Shortly after the application for variance was filed, the Joint Applicants and the Commission's Staff filed a non-unanimous stipulation and agreement that would purportedly settle all issues relevant to the joint application for variance.

The Commission will provide notice of the joint application to the general public and interested parties and set a deadline for intervention requests. If no proper party requests a hearing, the Commission may determine that a hearing is not necessary for a determination of the application.<sup>1</sup>



**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall provide a copy of this order to each party in the most recent general rate case of Kansas City Power & Light Company (ER-2016-0285) and KCP&L Greater Missouri Operations Company (ER-2016-0156), as well as to the county commission of each county within the service territories of Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the service territories of Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company, and to the media serving those service territories.
3. Any person wishing to intervene in this matter shall file an application to intervene no later than October 26, 2016. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission.
4. Any application to intervene shall indicate whether the applicant objects to the non-unanimous stipulation and agreement filed on October 12, 2016.
5. Any current party that wishes to object to the non-unanimous stipulation and agreement shall do so no later than October 26, 2016.
6. This order shall be effective when issued.




