ORDER AND NOTICE

Syllabus: This order gives directions for notice, sets an intervention deadline, and encourages electronic filing.

On May 9, 2002, the City of Foristell, Missouri, filed an application for the approval of the transfer of the assets of Eastern Missouri Utilities Co., Inc., to Foristell.

The application indicates, but does not clearly state, that Foristell seeks approval for the transfer of the assets of the now-defunct utility company, which transfer occurred in the year 2000. The company, according to Foristell, had been providing sewer service to "six residents" and now Foristell is providing that service.

Proper parties should be given notice and an opportunity to intervene in this matter. The Commission determines that notice of the application should be sent to interested persons and an intervention date set. Notice of this application should be sent by the Commission's Data Center by sending a copy of this order to the County Commission of Saint Charles County, County Administration Building, 201 North Second Street, St. Charles, MO 63301. The Commission further determines that the Information Office of the Commission should provide notice to the members of the General Assembly representing Saint Charles County and to the newspapers that serve Saint Charles County, as listed in the newspaper directory of the current Official *Manual of* the State *of Missouri*.
