## **STAFF'S STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through the Missouri Public Service Commission's ("Commission") Staff Counsel Department, and notifies the Commission of the status of Staff's recommendation in the pending file as follows:

- 1. In a filing today in File No. EO-2012-0070, the decommissioning trust fund case of Union Electric Company d/b/a Ameren Missouri, the Staff advised the Commission that the Staff is still engaged in discussions with Ameren Missouri. As a consequence, the Staff requested in File No. EO-2012-0070 additional time up to and including April 27, 2012 to file a Staff recommendation.
- 2. The Staff stated in its March 16, 2012 Status Report that it had basically reached agreement with Kansas City Power & Light Company ("KCPL") on the terms of a stipulation and agreement in the instant proceeding and requested additional time to March 28, 2012 to complete the stipulation and agreement. The Staff believes that is still the case and that basically agreement has been reached with the Office of the Public Counsel ("Public Counsel"). It is March 28, 2012, and KCPL, Public Counsel, and the Staff are engaged in finalizing the language of said stipulation and agreement. Thus, the Staff requests additional time until April 11, 2012 to file a stipulation and agreement in File No. EO-2012-0068, although the Staff believes a

stipulation and agreement may be able to be filed in File No. EO-2012-0068 before April 11, 2012.

WHEREFORE, the Staff reports that it believes that the Staff, Kansas City Power & Light Company, and the Office of the Public Counsel have basically reached agreement on the terms of a stipulation and agreement, and the Staff requests additional time up to and including April 11, 2012 for the parties to finalize stipulation and agreement language, to file a stipulation and agreement in the instant proceeding.
