On November 13, 2017, Broadview Networks, Inc. filed an application with the Missouri Public Service Commission for an expansion of Certificate of Service Authority to provide basic local exchange telecommunications service in the state of Missouri. The Commission published notice of the application and set a November 27, 2017, deadline for interested persons to request intervention. No applications to intervene have been filed.

The Commission's Staff was ordered to file a pleading no later than December 13, 2017, indicating a date when it would file a recommendation. Staff filed a status report on November 28, 2017, stating that it will file a recommendation by December 29, 2017. The Commission will establish that date for Staff to file its recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than December 29, 2017, the Staff of the Commission shall file its recommendation regarding this application.

2. This order shall be effective when issued.
