#### ORDER ESTABLISHING TIME TO RESPOND

On December 7, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed an application requesting that the Commission approve modifications to its Technical Resource Manual (TRM). Evergy wants to modify its TRM to incorporate final Evaluation, Measurement, and Verification results from Evergy's program year 1 in its Missouri Energy Efficiency Investment Act (MEEIA) Cycle 3.

In support of its proposed modifications, Evergy states that the modifications were provided to Commission Staff (Staff) and that Staff reviewed the modifications and expressed no concerns. The Implementation Team and Evergy's contractors also reviewed the proposed modifications. Evergy asserts that the modifications will not require any adjustment of the MEEIA portfolio's goals.

Evergy requests that its TRMs be approved to be effective January 1, 2023, to align program tracking data and program evaluation data.

Since Evergy represents that Staff has expressed no concerns with the proposed TRM modifications, the Commission will set a time for any responses to Evergy's application to modify its TRM.

#### THE COMMISSION ORDERS THAT:

- 1. Any responses or recommendations concerning Evergy's application to modify its TRM shall be filed no later than December 16, 2022.
  - 2. This order is effective when issued.
