On December 28, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed a substitute tariff sheet No. 49U under Tracking No. YE-2023-0110. Prior to the substitution, in a Commission order issued December 21, 2022, sheet No. 49U was approved to become effective on January 1, 2023. The Commission directed its Staff and Evergy to respond as to why a tariff substitution was made after the tariff was approved to become effective, yet before the Commission's order took effect.

Evergy filed a response stating that the substitution was made to correct an error in the revision number. The substitution changes 1st Revised Sheet No. 49U to 2nd Revised Sheet No. 49U, and was made pursuant to a Staff email request. Staff previously expressed this concern about Sheet No. 49U in its December 20, 2022, tariff recommendation, but did not request any substitution.

On December 30, 2022, Staff filed a response recommending the substitute tariff sheet be approved for service on and after January 1, 2023.

This substitution merely corrects a sheet numbering error and is not substantive.

Therefore, the Commission determines that further approval is not necessary for

2nd Revised Sheet 49U to take effect on January 1, 2023, as intended by the Commission.

For that reason, 2nd Revised Sheet 49U will become effective on January 1, 2023.
