**STAFF MOTION**

COMES NOW the Staff of the Missouri Public Service Commission and for its motion, states as follows:


1. On August 30, 2011, Accutel of Texas, Inc. (“Accutel”) requested the Commission cancel its certificate of service authority to provide basic local exchange telecommunications service. Accutel was granted authority to provide interexchange telecommunications services in File No. TA-2000-410. A copy of that request is attached.

2. Because Accutel requested cancellation of its service authority and it is not providing basic local telecommunications services in Missouri, Staff recommends the Commission cancel its certificate.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

WHEREFORE, Staff recommends that the Commission cancel the Certificate of Service Authority for Accutel of Texas, Inc. to provide basic local telecommunications service in Missouri, and cancel any accompanying tariff(s).
