ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023 Effective Date: August 23, 2023

On March 28, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificate of service authority of Cathect Communications, Inc. (Cathect or the Company) to provide basic local exchange telecommunications services in Missouri. In File Number CA-2021-0268, the Commission granted Cathect authority to provide basic local exchange services.

Staff's motion states that Cathect failed to submit an annual report due to the Commission for calendar year 2021. In addition, the Company failed to file its Statement of Revenue report and pay the annual assessment for fiscal year 2023. Staff recommended that the Commission cancel the Company's certificate of service authority.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. Cathect has not responded.

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Cathect shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of service authority to provide basic local exchange telecommunications services in Missouri, granted to Cathect in File Number CA-2021-0268, is canceled.
 - 2. This order shall become effective on August 23, 2023.
 - 3. This case may be closed on August 24, 2023.
