ORDER APPROVING ADDITIONAL COMPLIANCE TARIFF SHEET

Effective Date: June 21, 2010

On May 28, 2010, the Missouri Public Service Commission issued its Report and Order rejecting the tariff filed by Union Electric Company, d/b/a AmerenUE, and directing AmerenUE to file a revised tariff to effectuate the terms of the Report and Order. AmerenUE filed a revised tariff on June 8 in compliance with that order, and on June 16, the Commission issued an order that approved that revised tariff to be effective on June 21.

At Staff's request, AmerenUE filed an additional tariff sheet, number 98.7 of schedule 5, on June 10, and filed a separate motion asking the Commission to approve that additional tariff sheet to be effective at the same time as the other compliance tariff sheets. Staff's recommendation, filed on June 14, advised the Commission to approve all the compliance tariff sheets filed by AmerenUE, including sheet number 98.7. The Commission's June 16 order listed the specific tariff sheets it was approving, but neglected to list that additional tariff sheet.

The Commission has reviewed the additional proposed tariff sheet and concludes that the additional compliance tariff sheet is consistent with the Commission's Report and Order. Expedited approval of this revised tariffs is appropriate because the Commission

has found that the rates resulting from its Report and Order are just and reasonable and AmerenUE should not be forced to wait an inordinate amount of time to implement those rates. Thus, for good cause shown pursuant to Section 393.140(11), RSMo 2000, The Commission will approve AmerenUE's tariff sheet to become effective for service rendered on and after June 21.

THE COMMISSION ORDERS THAT:

1. The additional proposed electric service tariff sheet submitted under Tariff Tracking No. YE-2010-0697 by Union Electric Company, d/b/a AmerenUE, is approved, effective on and after June 21, 2010. The specific tariff sheet approved is:
