ORDER DENYING MOTION TO CONSOLIDATE CASES AND ADD PARTIES

Issue Date: September 22, 2022 Effective Date: September 22, 2022 On August 18, 2022, The Office of the Public Counsel (OPC) filed a motion to consolidate cases and add parties in the 15 cases captioned above. The certificate of service attached to OPC's motion indicates that it was mailed, hand-delivered, transmitted by facsimile or electronically mailed to all counsel of record. None of the applicants are represented by counsel, and none of the applicants are named on the certificate of service, so the certificate fails to indicate service on any applicant party.¹

In its motion, OPC fails to allege that the cases share common questions of law or state facts showing that consolidation is appropriate or necessary.² Without such allegations, OPC's motion is insufficient.

On September 20, the Staff of the Commission filed a response to OPC's motion to consolidate, stating that the named cases involve related questions of law and fact, and explains that facts alleged in those cases show that consolidation would be administratively expedient and would simplify these proceedings. Staff's certificate of service also fails to indicate service on any applicant party.

All parties in the named cases are self-represented, and only qualified to represent themselves. No attorney has entered an appearance to represent the parties jointly in a consolidated case. It is not feasible to consolidate cases without an attorney to represent the applicants collectively in the consolidated case. It may be feasible to consolidate these cases for purposes of conducting a single hearing, but that question can be addressed later.

Along with its motion to consolidate cases, OPC included a request to add Stacy Castrogiovanni, William Hobbs, and Carrie Hobbs as applicant parties, since all signed a petition asking the City of Butler to release their electric service agreement to Osage Valley Electric Cooperative. None of those three persons has submitted an application to the Commission or affirmatively indicated in writing that he or she wishes to apply to the

Commission for change of electric supplier, and OPC has not contacted these parties to determine their wishes. As such, OPC has failed to state sufficient criteria to add these persons to the case.

File No. EO-2023-0050, filed by Scott Nameth does not include an address for service. A notice of deficiency has been issued in that matter and the Commission will not act on that application, or consolidate it with other applications, until Mr. Nameth files confirmation of his address with the Commission.

The Commission will deny OPC's motion to consolidate cases and add parties.

THE COMMISSION ORDERS THAT:

- 1. OPC's motion to consolidate cases and add parties is denied.
- 2. This order shall be effective when issued.
