On January 11, 2006, Kansas City Power & Light Company and the United States Department of Energy, on behalf of the National Nuclear Security Administration, filed a Joint Application. That application requests that the Commission find that it is reasonable and prudent for KCPL to relocate and reconfigure a substation that serves DOE-NNSA.

The Commission has determined that the Data Center of the Commission shall serve a copy of this order on all parties in KCPL's experimental regulatory plan case, which was Case No. EO-2005-0329. Persons wishing to intervene shall have 20 days from the date of this order to file an application with the Secretary of the Commission and shall send a copy of the application to all parties as directed below.
