## NOTICE ACKNOWLEDGING VOLUNTARY PARTIAL DISMISSAL

Issue Date: July 30, 2009

The Missouri Public Service Commission is acknowledging that Jerry and Sharon West (“the Wests”) and WIK, L.L.C., (“WIK”) have partially dismissed their applications by filing a “Notice of Dismissal” (“the notice”).

The Wests filed their application on November 14, 2008. On June 1, 2009, the Commission granted WIK’s motion for leave to intervene, which adopted the Wests’ application.<sup>1</sup> The Wests’ application seeks a change of electrical supplier for part of their property.<sup>2</sup> Such property includes the parcel at 7335 Weldon Springs Road, Dardenne Prairie, Missouri. That parcel is the subject of the notice.

The notice is subject to the following regulation:

An applicant . . . may voluntarily dismiss an application . . . without an order of the commission at any time before prepared testimony has been filed or oral evidence has been offered, by filing a notice of dismissal with the commission and serving a copy on all parties[.<sup>3</sup>]

The Wests and WIK served a copy on all parties by filing the notice in the Commission’s electronic filing and information system on July 30, 2009, which sends notice to all

counsel of record.<sup>4</sup> No party has filed any prepared testimony or offered any oral evidence. Therefore, the notice partially dismissed the applications upon filing, without an order of the Commission.

**THE COMMISSION ORDERS THAT:**

1. The application of Jerry and Sharon West is dismissed as to 7335 Weldon Springs Road, Dardenne Prairie, Missouri, effective July 30, 2009.

2. The application of WIK, L.L.C., is dismissed as to 7335 Weldon Springs Road, Dardenne Prairie, Missouri, effective July 30, 2009.
